1. The above posts are purely temporary, time bound and co-terminus with the project. Appointment will be based on the performance and fund availability.
2. Candidates having more than one eligible qualification shall have to choose only one for selection process.
3. Age relaxation*: The relaxation in upper age limit will be applicable as per Central Govt. to SC/ST/OBC/PwD and women candidates.
4. Online applications received will be shortlisted and eligible, shortlisted candidates will be called for interview on the prescribed dates which will be displayed in ICAR-IISR website (<https://iisrindore.icar.gov.in>) or be informed through email.
5. Shortlisted candidates will have to bring a copy of filled in prescribed application form along with the self-attested xerox copies of the original documents of the qualifications and a recent photograph pasted onto the scan application.
6. The selected candidates will be required to produce all the original documents and medical & Character certificate at the time of joining.
